1) 29 claims amounting to INR 93,44,835.18 pertaining to employees who are not on the payroll of RCIL as per company records.

2) The relevant portion of the claim shown under head "Amount Rejected" includes (but not limited to):

a) Claim for which payment has already been made as per the records of the corporate debtor

b) Claims which are not contractually due

c) Claim pertaining to PLI and SIP of employees who have resigned prior to the ICD period . As per policies of the Company PLI and SIP is payable to employees if they are on the rolls of the Company as on the date of disbursement. For the purpose of verification of claims pertaining to PLI/SIP, we have inter alia taken into account the relevant policies, the provisions made in the books of account of the Corporate Debtor and the allotment made to employees as per the records of the Corporate Debtor. Further, the Cut-Off Date has been considered as the date of disbursement to determine eligibility for payment to employees. Therefore , it is rejected.

3) 73 claims amounting to INR 20,846,553.69 pertaining to gratuity of employees who resigned prior to the insolvency commencement date .The claims for these employees have also been filed under Form E by the authorized representative. We have considered the claim filed under Form E .
