Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015, it is hereby informed that, pursuant to decision taken by the committee of creditors at the 35th meeting of the committee of creditors of Reliance Communications Limited (“RCOM” / “Company”) for closure of certain foreign subsidiaries where there are no operations / revenues and winding up / closure of such subsidiaries would result in saving of cost, the Company had initiated the process for closure of Reliance Communications (Australia) PTY Limited (a step down subsidiary of RCOM); and on June 13, 2023, RCOM has received a letter dated June 04, 2023 issued by the Delegate of the Australian Securities & Investments Commission (“ASIC”) notifying about the deregistration of Reliance Communications (Australia) PTY Limited (a step down subsidiary of RCOM), as a company in terms of the relevant provisions of the Corporation Act 2001 (a statute enacted by the Parliament of Australia) with effect from June 04, 2023.
